1. Executive Session:

Brad asked the School Committee to appoint a Committee member for the bargaining team and to provide him with direction to move forward. Brad noted that based on school counsel's advice, negotiations must be done at this time and done in good faith.

The School Committee discussed the length of the custodial contract, including COLAs. The Committee also discussed pursuing an independent third party assessment by Edvocate.


